## **PAYMENT OF PERPETUAL SECURITY DISTRIBUTION**

Daiwa House Asset Management Asia Pte. Ltd., as manager of Daiwa House Logistics Trust ("**DHLT**") wishes to announce that in accordance with the terms and conditions of the JPY 3.0 billion subordinated perpetual securities of DHLT ("**Perpetual Securities**" and each, a "**Perpetual Security**") issued to Daiwa House Industry Co., Ltd. (the "**Sponsor**") on 26 November 2021 (the "**Issue Date**"), HSBC Institutional Trust Services (Singapore) Limited, as trustee of DHLT has elected to pay a distribution of 2.95% per annum for the period from 30 September 2023 to 30 March 2024 amounting to JPY 44,371,233 (subject to withholding tax) in respect of the Perpetual Securities in issue to the Sponsor, being the holder of the Perpetual Securities in issue on the record date falling 15 business days before the date of payment of such distribution, which shall be on 1 April 2024<sup>1</sup>.

Under the terms and conditions of the Perpetual Securities, the Perpetual Securities confer a right on the holder as at the relevant record date to receive distributions from the Issue Date as at the applicable distribution rate (the "**Distribution Rate**") semi-annually in arrears on 30 September and 31 March of each year, and from the Issue Date to the date falling five years from the Issue Date, the applicable Distribution Rate shall be 2.95% per annum.
